Founded in 2010, Care Fund is Arizona's only non-profit organization dedicated to providing mortgage and rent assistance during a child's extended health crisis.

Having assisted more than 950 families across the state since the inception of the program, Care Fund is committed to supporting families of critically ill or injured children who endure financial hardship - no parent should have to choose between working to pay their mortgage or rent and caring for their ill child.

Mortgage & Rent Assistance - Since inception, Care Fund has provided:



\$2.47 Million in mortgage and rent assistance has been provided statewide to Arizona families to keep them in their homes

950 seriously ill or injured children, from birth to age 18, with 80+ primary diagnoses have been assisted

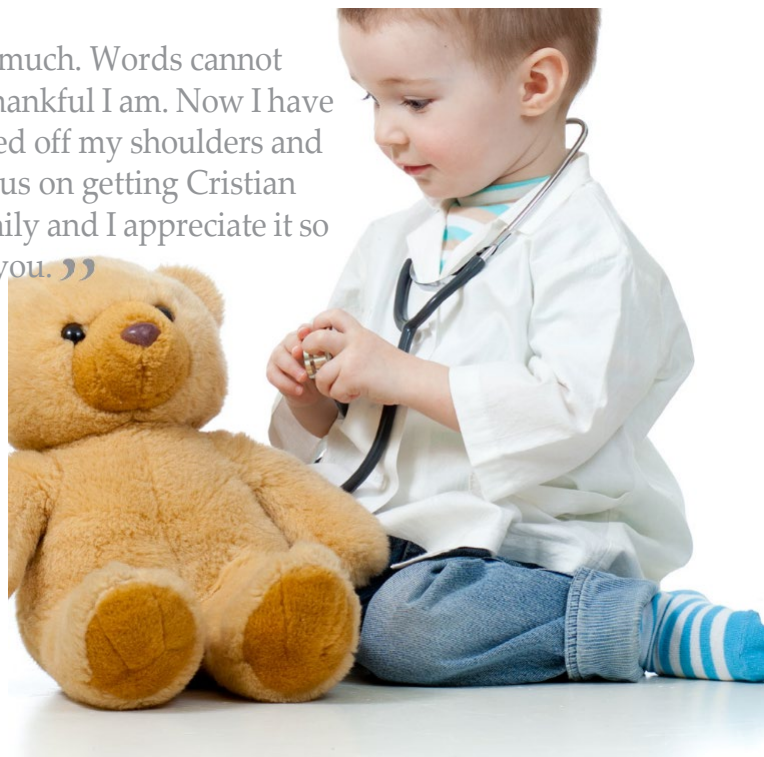

Arizona Tax Credit for Qualifying Charitable Organizations

Care Fund is recognized by the Arizona Department of Revenue as a Qualifying Charitable

Organization. Care Fund donors who pay income tax in Arizona may claim the tax credit support for QCOs. Eligible contributions made on or before April 15th may be applied to either the current or the preceding taxable year.

Taxpayers filing as:

- "single" and "head of household" status may claim a maximum credit of \$400
- "married filing separate" may claim a maximum credit of \$400
- "married filing jointly" may claim a maximum credit of \$800
